**MOTION AND NOTICE OF WITHDRAWAL OF INTERVENTION  
AND OF REQUEST FOR REHEARING OF THE  
OREGON NATURAL DESERT ASSOCIATION**

Pursuant to Rules 212 and 216 of the Commission’s Rules of Practice, 18 C.F.R. §§ 385.212, -.216, the Oregon Natural Desert Association (“ONDA”) submits this Motion and Notice of Withdrawal of Intervention and of Request for Rehearing in the proceedings for Docket No. CP-09-54-000 and -002. ONDA is a non-profit public interest organization whose mission is to protect, defend, and restore forever the health of Oregon’s native deserts.

Ruby Pipeline LLC, a Delaware limited liability company (“Ruby”), is proposing to build and operate a natural gas pipeline approximately 675.5 miles in length, extending from Opal, Wyoming to Malin, Oregon (the “Ruby Pipeline”). Ruby is currently seeking approvals for the Ruby Pipeline from various federal and state agencies, including the Federal Energy Regulatory Commission (“FERC”). ONDA is an intervenor in the FERC proceedings regarding the Ruby Pipeline and has filed a Request for Reconsideration of the Certificate of Public Convenience and Necessity which FERC issued for the Ruby Pipeline on April 5, 2010 (the “Certificate”). Based on discussions and negotiations with Ruby and other intervening events, ONDA does not oppose the permitting and construction of the Ruby Pipeline as proposed in the Final Environmental Impact Statement and certificated by FERC. Accordingly, pursuant to Rules 212 and 216 of the Commission’s Rules of Practice and Procedure, 18 C.F.R. §§ 385.212, -.216, ONDA hereby withdraws its intervention on March 31, 2009 in FERC Docket No. CP09-54-000
