VIBRANT, PROTECTED HIGH DESERT WILD LANDS

Today, we're working to protect, defend and restore stunning, ecologically significant areas in the Central Oregon Backcountry, Greater Hart-Sheldon Region, John Day River Basin, Steens Mountain Region and the Owyhee Canyonlands.









For nearly 30 years, ONDA has been the sole organization working exclusively on behalf of Oregon's high desert. With your support, our efforts have led to significant accomplishments: the creation of Steens Mountain, Oregon Badlands and Spring Basin wilderness areas; the improvement of water quality for spawning steelhead and salmon in the John Day River Basin; and the removal of roughly 2,400 tons of obsolete barbed wire fence from Hart Mountain National Antelope Refuge.

Our vision for 2015 includes:

Legislation for John Day River Basin wilderness areas – Cathedral Rock, Horse Heaven and Sutton Mountain will come before Congress backed by strong local support.

Congressional support for permanently protecting the Owyhee Canyonlands will be announced, buoyed by new allies who cherish the region's amazing 2.1-million acres of rivers, canyons and wildlife habitat.

Core Greater sage-grouse habitat will be safeguarded with strong land management strategies, particularly in the bird's most critical strongholds in the Greater Hart-Sheldon Region and Owyhee Canyonlands.

Independent land stewards will add more manpower to our already vibrant restoration efforts. Trained through a new part of ONDA's wilderness stewardship program, they will assist in monitoring and collecting data on the health of the high desert.

Oregon west-side ONDA members and supporters will have even more reason to be inspired by the high desert and active in efforts to protect it with the addition of a new Portland-based staff member dedicated to supporter engagement.






