

# **Internship Announcement**

POSITION: Hillis Intern

REPORTS TO: Wildlands Coordinator

LOCATION: Bend, Oregon or other Central Oregon location CLASSIFICATION: Limited duration part-time paid internship

DURATION: 10 to 12 weeks in summer 2024

### **DESCRIPTION**

Oregon Natural Desert Association (ONDA) is a conservation organization with a mission to protect, defend and restore Oregon's high desert. With offices in Bend and Portland, Oregon, we represent more than 18,000 members and supporters in the state and across the country. ONDA's Hillis Internship was launched in 2021 to honor one of those members, Harv Hillis, and his passion for desert conservation and stewardship. The Hillis Internship Program provides early career individuals with valuable learning and professional growth opportunities while contributing to the conservation and restoration of Oregon's desert landscapes.

ONDA is pleased to offer an internship in summer 2024 for an aspiring conservation advocate to survey and record bird use at Lake Abert, supporting long-term monitoring efforts by two area expert ornithologists. Lake Abert, located near Paisley, Oregon, is a large hypersaline lake that provides vitally important habitat for hundreds of thousands of migratory birds traversing the Pacific Flyway on spring and fall migrations. Unfortunately, water inputs to Lake Abert have been altered by upstream management, causing the lake to dry up some years and threatening the delicate ecosystem and bird use at the lake. The data collected are shared with numerous organizations and agencies tracking how lake levels and drying conditions might affect the diversity and dependency of avifauna on the lake.

This a part-time internship of 8 to 12 hours per week for ten to twelve weeks beginning in June 2024. The opportunity will involve remote work in the field for 8-12 hours, including travel time. It is preferred that the applicant live in Bend or another community centrally-located to Lake Abert. ONDA will cover travel costs and supply equipment and supplies as needed. Field visits may require physical exertion such as prolonged hiking over rough or steep terrain and standing in a stationary position for long durations. The intern will be expected to conduct duties in a safe and orderly manner so as not to endanger self or others, or damage property with which they are entrusted.

#### **SKILLS GAINED**

This internship will involve working alongside and networking with knowledgeable and passionate ornithologists and conservation advocates. Upon completion of the internship, the intern will have gained valuable and directly transferable experience in wildlife surveying and methodology. They will develop a broad understanding of wildlife and water management, natural history and legislative and administrative policies applicable to Lake Abert. Finally, they will make new friends and important contacts with ONDA staff, members and supporters dedicated to conservation of this unique and vital ecosystem.

## **ELIGIBILITY & DESIRED QUALIFICATIONS**

The Hillis Internship is open to early career individuals with a demonstrated interest in ONDA's conservation mission. Early career individuals are defined as:

- 1) Students currently enrolled in a post-secondary educational institution (e.g., undergraduate, graduate, 4-year university, 2-year college, trade school, etc.);
- 2) Recent graduates who have completed a post-secondary degree or certificate within the past 12 months, or
- 3) Independent students who are pursuing an education or experience formal or informal, within or without the bounds of a traditional educational institution in a subject area related to ONDA's mission and the internship.

Ideal candidates are those with some field experience, avian species identification and/or the patience to accurately conduct bird counts. All candidates must have a valid driver's license.

#### **COMPENSATION**

This internship is paid at a daily rate, equivalent to \$20/hour based on scope of field work. Travel expenses will be reimbursed.
